

# Terms and conditions of the sports hall

These terms and conditions are intended to ensure order, safety and protection of users and visitors of the sports hall of the König's Mill guesthouse in Háj u Loučné pod Klínovcem, p.1265 c.c. Háj u Loučné pod Klínovcem (further referred to as "sports hall"). Users and visitors are obliged to abide by these terms and conditions and to follow them unconditionally.

### **I. Purpose of the sports hall**

The sports hall is intended for the following sports activities: tennis, badminton, volleyball, football, aerobics (yoga), netball and streetball. The sports hall is available for all interested parties on pre-arranged dates. The sports hall includes changing rooms and washrooms, which are located in the "König's Mill" guesthouse.

### **II. Administration of the complex**

1. All indoor facilities are managed by a manager appointed by the operator, who also ensures regular maintenance of the playing field and clean changing rooms, showers and toilets. In winter, he/she shall ensure that the sports hall is heated to a minimum of 10 C.
2. The manager is entitled to expel users from the sports hall who do not follow his instructions and do not comply with terms and conditions of the sports hall.
3. Neither the operator nor the manager shall be liable for the left belongings, money and other valuables of the users and visitors of the sports hall.
4. The terms and conditions of the sports hall must be posted at the entrance to the sports hall and on the operator's website.

### **III. Terms and conditions**

1. Everyone who enters the sports hall area becomes a user or visitor. Persons under the age of fifteen may use the sports hall and its facilities only under the supervision and responsibility of persons over the age of eighteen. By entering the sports hall, visitors confirm that they are fully fit to participate in the particular sport activity

2. To maintain safety, order and protection of property are users and visitors of the sports hall obliged to respect the operating rules and obey the instructions of the administrator, persons designated by the administrator or supervisors. Visitors of the sports hall shall carry out the activity at their own risk, in a safe and considerate manner, especially towards senior citizens and young children.

3. The manager shall supervise the maintenance of order and terms and conditions, take orders and reservations from users, and lend sports equipment. He/she keeps operational records of orders received and equipment loaned.

#### **4. The user or visitor is obliged to:**

**a) compensate for any damage or loss caused by them,**

**b) use all facilities and areas of the sports hall only for their intended purpose,**

**c) enter the sports hall only in clean indoor shoes, shoe covers or suitable slippers.**

#### **5. Users or visitors are prohibited from:**

**a) bringing area unrelated objects to the sports activity into the sports hall,**

**b) tampering with any of the sports hall's operating equipment unless authorised to do so by the manager or operator,**

**c) smoking and handling open flames in any area of the sports hall**

**d) bringing food into the sports hall; drinks may only be brought into the sports hall in plastic containers**

**e) hanging on goals, protective nets, basketball hoops and arbitrarily damaging the equipment of the sports hall.**

6. The operator shall not be liable for any damage to the health or property of users or visitors caused by carelessness or failure to comply with the operating rules, whether during sporting or other activities. Furthermore, the operator shall not be liable for health injuries caused by improper use of sports equipment.

7. In the event of a breach of the terms and condition, the visitor may be ejected from the sports hall by the manager or his/her designees without refund of the admission or rental fee.

Compensation for any damages caused by the visitor will be enforced according to the applicable legislation of the Czech Republic
